#### 10 Melrose Crescent, Menora

The house, shown above in 1959, was constructed as a 9-room brick dwelling by builder Chas Grayson in 1936 for Mrs M Catts at a contract price of £2400. The architect was Mr. C L E Harrison. Abraham and Mary Catts were initial residents. Abraham was a restaurant proprietor with the Monte Carlo Café in Barrack Street. Walter (Wally) and Marie (nee Vander Velde) Tauss then lived there 1949-1970. Dr Tauss arrived in Australia in 1938 from Austria, and was an academic with many letters after his name – MBE, PhD, BSc, Dip.Soc.Wk, MAPsS, AAPSW, APTC, AASA(Sen), FAIM, MAIA, receiving his PhD for a thesis on "Neurotic Manifestation, Predisposition and Everyday Stress". Wally was awarded an MBE in 1961 for work with the RAAF and assisted with setting up of the Temple David in Perth and was a keen member of the Mt Lawley Tennis Club.



## **From the Archives**

## The army at Perth College in 1942-1943



The 3<sup>rd</sup> Australian Corp was responsible for the defence of Western Australia in 1942-1944. They were formed in April 1942 from Western Command which itself was formed in October 1939 and was based at the Swan Barracks in Francis St, Perth, the building that is now heritage listed and sits between the Museum and Beaufort St. So, in April 1942, the 3<sup>rd</sup> Australian Corps' headquarters were established at Perth College (PC), Mt Lawley, with Lieutenant Gordon Bennet appointed Corps Commander (see his office shown in the adjacent

map, marked \*). In August 1942, the  $2^{\rm nd}$  Division from NSW joined the  $3^{\rm rd}$  Australian Corps although they had


their headquarters in Guildford, joining the Victorian 4<sup>th</sup> Division which had arrived in WA in March 1942.

According to excerpts from memoirs of WF45679 Sigwm Joy See (later Mrs Joy Tufnell), a copy of which is held in the Mt Lawley Society archive:

The 46 Heavy Wireless Section of the Australian Women's Army Service (AWAS) Signals was also based at PC from July to November 1943. Despite there being twelve girls still at the school, half of the Hvy W/T section was transferred from Kalamunda Wireless Station to the newly created Dug-Out at PC (see map, marked \*\*). The Dug-Out was a unique place, an after-thought hole in the ground in the backyard of Perth College, measuring 8ft square by 6ft high and the walls were sand-bagged to keep the earth in place. It had a tent top with camouflaged tent-fly stretched above it. The entrance pathway was down a gradual decline with sandbags on either side and, although the door was made of sturdy wood, the rain did penetrate beneath on occasions. It was cold and miserable for the first 2-3 months with only a small kerosene heater for warmth. The Wireless Receivers were installed so the signal women could tune in themselves, while the transmitters remained in Kalamunda and were manned by the other half of the Section known as "Remote Control".

The signal women at PC worked three 8 hour shifts per day, 7 days per week, operating only two Wireless links – 8LL to Pippingarra in the north of WA, and Fortress Signals at Albany and Rottnest. When stationed at the Dug-Out, signals women were allowed to live at home but the two groups alternated on a monthly basis. They certainly took advantage of being in the city every second month, attending dances, the pictures and catching up with Civvy friends. The system worked well but they were noticeably busier than previously. 3rd Australia Corps Signals office men were running back and forth from their "cosy" warm office in the main College building with bundles of coded messages to be sent out, and they collected the incoming messages from the signals women. MUCH LATER, we were to discover that over 50% of those messages were DUMMY! The heavy volume of traffic on the airwaves with falsely coded messages was supposedly to confuse the Japanese. As the situation of the War changed, by November 1943, the signals women were moved again. The old Dug-Out was used for wireless monitoring and interception.

### The formation of the Mount Lawley Society 46 years ago



On the afternoon of Sunday 23<sup>rd</sup> October 1977 at Ferguson Hall, corner of Glenroyd Street and Lawley Crescent, the Mount Lawley Society came into being as shown in the Press Release on the left. A Steering Committee was formed with Don Urguhart (interim President) and Peta Townsing (interim Secretary) and other members being Russell Moffet, Frank Hemsley, John McGuire, Brian Haines, Ed Scull and Shirley Mulcahy. The inaugural AGM was then held at Ferguson Hall on Sunday 20<sup>th</sup> November, 1977 with 60 people present, and the first Committee was elected as Don Urquhart (President), Peta Townsing (Secretary), Phyl Hamsley (Treasurer), and general members Jeff Currie, Angelo Christou, Tim Johnston, Hannah Downie and Richard Saulsman.

It can be seen from the adjacent press release that the first objective and principle motivation was to preserve the character of Mt Lawley as many of the old homes were being demolished for development. The second objective then mentions the specific preservation of "St Faith's". This was originally the old house of the Connaughton family at "Loughrea", 705

Beaufort Street, built in 1914. They were neighbours of Samuel Copley who lived at "Mayroyd", 707 Beaufort Street. Copley, together with RT Robinson and his brother Ben, purchased 730 acres (300 ha) of land to form the Mount Lawley estate which they sub-divided into quarter-acre blocks. "Loughrea" was offered for sale in 1958 for £10,000 and it was purchased by Perth College. In 1959 Perth College renamed the house "St Faith's" providing such functions as dressmaking and stenography in separate rooms, accommodation for several resident mistresses, and a proper meeting room for the old girls. By 1963 "St Faith's" was converted to house twenty boarders – "trusted older girls, who were even allowed to wear shorts". Perth College subsequently demolished

the building in 1977 to make way for the current playing fields. Indeed, the interim President of the Mt Lawley Society (Don Urqhuart) wrote to the Archbishop of Perth on 3 November 1977 regarding the fate of "St Faith's":

"Your Grace, I think it is only proper that you should be made aware of the amount of ill-will and odium which is being created by the decision of the Council of Perth College."

Perth College also purchased Copley's home "Mayroyd" and it was demolished in 1981.

## 100 years ago – Inspection of Local Park

The following article was published in the *West Australian* on Saturday 22 September 1923 on page 10 and is transcribed as published (ie no paragraphs).

With the view of affording representatives of the cricket, football, bowling, tennis, and other sporting associations, an opportunity of inspecting the reserve; at Mt Lawley recently vested<sup>1</sup> in the Perth Road Board, a visit was paid to the locality on Thursday last<sup>2</sup>. The board was represented by Messrs. E. W. Hamer<sup>3</sup> (chairman). R. T. Robinson<sup>4</sup>; J. Tyler, D. Keane, F. A. Mansfield, and Crain, with the secretary (Mr. Plunkett) and engineer (Mr. Hargrave). Professor Shann and Mr. Keall attended on behalf of the golfing association, and Mr. W Orr represented the W.A. Football League. The W.A.C.A. was represented by Mr. Robinson, the Lawn Tennis Association by Mr. Warren, and the British Soccer Association by Mr. Robinson Cook. Mr. J. G. Braithwaite, Perth city gardener, was also present. The party motored out to the reserve and the afternoon was spent in an inspection of the areas allotted for bowls and tennis. Australian and soccer football, cricket, and golf, and also for parks and; gardens and children's playgrounds. Subsequently an adjournment was made to Waurina<sup>5</sup>, the residence of the chairman, at Mt. Lawley, where refreshments were served, and a pleasant half-hour was spent. Gratification was expressed, by the representatives that such a fine area should have been granted by the Government for recreation purposes so close to the city, and attribute was paid to the far-seeing policy adopted by the Premier<sup>6</sup> in reserving the land for all time to come.

### The Land Act, 1898. ORDER IN COUNCIL.

Corr, No. 5192/96.

WHEREAS by Section 42 of "The Land Act, 1898." it is made lawful for the Governor to direct that any Reserve shall vest in and be held by any Municipality, Road Board, or other person or persons to be named in the order, in trust for any of the purposes set forth in Section 39 of the said Act, or for the like or other public purposes to be specified in such order, and with power of leasing for any term not exceeding twentyone years from the date of the lease: And whereas it is deemed expedient that Reserves A18324 and A18325 should vest in and be held by the Perth Road Board; Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned Reserves shall vest in and be held by the Perth Road Board, with power to the said Perth Road Board to lease the whole or any portion of the said Reserve for any term not exceeding twenty-one years from the date of the lease. Provided that any such lease shall be first approved by His Excellency the Governor.




